Rebates will not be paid for ineligible or incomplete applications. Rebates will be paid in the form of a credit issued on the utility account. Multi-Family rebates must be pre-approved by the Conservation Coordinator

Application Instructions:

1. Review the acceptance terms on this application.
2. Submit this application for pre-approval – prior to installing qualified toilets with Part I completed. A copy of the approved application will be returned at which time the installation may be done. Applications submitted that are not pre-approved will be denied.
3. Purchase and install qualified toilets in units and return a copy of the approved applications with the following information:

- a. Dated Sales Receipt or invoice which clearly details the following
  - i. Retailer/Contractor name and address
  - ii. Number, brand and model number of toilet purchased – **Must be WaterSense labeled toilets** circled or highlighted.
- b. Complete Part II – Project Completion
- 4. Keep a copy for your records
- 5. Mail the completed and customer-signed application together with all supporting documents to:

Allow six weeks from receipt of complete application and documents to receive your rebate.

I understand and agree that the water utility account for the property listed (page 1) may be monitored by the City of St. George for the sole purpose of evaluating prior and post rebate water use in order to determine the effectiveness of the program. I understand that submission of this application DOES NOT relieve me of my obligation to pay my utility account on time and in full while waiting for the rebate to be processed.

### Rebate Availability

City rebate program has been approved by the City Council and may be subject to change or modification at any time. I understand the rebate application must be approved prior to installation of qualifying toilets. Toilets and must be purchased and installed on or after July 1, 2010. Applications must include all information requested. Failure to provide this information may result in the delay or denial of the rebate.

### Rebate Qualification

This program is open to existing City of St. George multi-family water utility customers. This program offers a rebate replacement an older (pre-2000) model toilet with a **WaterSense** labeled toilet. A list of qualifying models can be found on the EPA's WaterSense website: <http://www.epa.gov/watersense>. This program will run from July 1, 2010 until June 30, 2012 or funds are depleted, whichever occurs first. The original meter set date will be used to determine the age of the toilet(s) being replaced, i.e. if the set date is December 31, 1999 or earlier, applicant is eligible for the rebate.

### Application Details

Application must be pre-approved for the rebate prior to the installation of qualifying toilets. This is done so funds can be reserved and the rebate paid after the project is complete. Applications are subject to verification by City. If your application is selected for verification, it will not be processed until the verification process is satisfactorily completed. Rebates will be paid in the form of a credit issued on the utility account.

**City is not responsible if your retailer or contractor provides inaccurate information about the amount and/or conditions of the actual rebate and City will not pay rebates for fixtures that are mislabeled or misrepresented by dealers regarding rebate qualifications.**

### Rebate Limitations and Limitation of damages

Payment of the rebate by City does not warrant the performance of qualifying/installed replacement toilet and does not guarantee any specified amount of water or cost savings. The customer shall independently evaluate any information related to the qualifying toilet.
