The following items will need to be submitted to begin the process of obtaining a *for-hire driver* business license. Please note that the City may require additional information not listed on this form.

- Notarized For-Hire Driver Application
- Application Fee (\$50.00)
- An original background check issued by the Utah Department of Public Safety Bureau of Criminal Identification dated no older than 180 days prior to the date of the application.

- Triple I Background Check (ONLY if you have not resided in Utah for the past 5 years)

- Driving History for the past seven (7) years from **all** states the driver has held a driver's license during that time.
- One (1) color copy of the applicant's Utah driver's license clearly showing the driver's face and information.
- One (1) passport size photographs of the applicant taken within 30 days of the application date.

Please note the City will maintain copies of the applicant's application, supporting documents, proof of identity and other submitted documents. These copies will become public records available for inspection on demand at the City offices whether or not a certificate is denied, granted or renewed. To the extent permitted by State and/or Federal law, the applicant's BCI background check as well as the Triple I criminal background check and driving record shall remain a confidential, protected, private record not available for public inspection. The disqualifying status, denial or suspension of a certificate can be found in the City Codes and Ordinances Article B. For-Hire Vehicle Services 3-20-6.
