



St. George Police Department



The mission statement of the St. George Police Department is to work with the citizens of St. George to preserve life, maintain human rights, protect property, and promote individual responsibility and community commitment. Despite the everyday challenges are community faces, things are going well in the Police Department. We have implemented a Community Action Team (CAT) concept where officers are assigned to an area of town for a year to work with the resident representatives to solve the problems and issues on the neighborhood level. For example, one school had traffic problems picking up and dropping off students. Utilizing the CAT concept, other agencies were involved to put up signs and paint the roadways to direct traffic and promote safety for the kids. Another elementary school needed a crosswalk which was also facilitated using the CAT team approach. Currently, officers are working with other City departments for street lights in one neighborhood and park improvements in another. From drug houses and junky lots to safety fairs and neighborhood meetings, officers and citizens working together have been able to improve the quality of life for many neighborhoods in St. George. Gangs and Drugs in St. George

With the presence of drugs and an emerging gang influence in St. George, the Washington County Gang and Drug Task Force has had a very positive impact by removing meth houses and documenting individuals associated with gangs. A very aggressive anti-graffiti removal program has kept these individuals from staking out their turf and eliminated the possibility to use graffiti to "communicate," as is happening in other communities. Working closely with

school resource officers, many juveniles and adults have been documented as being affiliated in the gang society. By keeping track of these individuals, it is possible to document their activities and hold them responsible for many of the crimes that would have otherwise gone unsolved. When a structure is "tagged" with graffiti and the graffiti cannot be removed, the person responsible can be charged with the replacement cost of that sign, wall or other structure. Many drug arrests and seizures have been made including one where over a pound of meth was hidden in a child's car seat. As Oxycontin and Lortab become harder to get, heroine is becoming more popular. The Gang and Drug Task Force is beginning to see new drug dealers fill the "vacancies" left by those arrested.

One solution is the ability to work with willing witnesses that can testify to what they have seen.

School resource officers are present in every intermediate, middle and high school in Washington County. These officers work closely with members of the Drug and Gang Task Force and the Investigations Divisions to solve crimes that are associated with juveniles. As these officers work with neighboring residents they have been able to solve many of the juvenile issues that spill over into the neighborhoods, including parking, trespassing and truancy. Thefts and graffiti cases have been solved largely due to the relationships that the officers have developed with students and faculty. Go to

Victim Services

The Victim Services Division of the Police Department has been extremely active assisting the victims of domestic violence. They are the victim's advocate through the court process helping the victims to have a voice, informing them of their rights, especially the right to

assist in how the perpetrator will be sentenced. Victim Services assists with protective orders and stalking injunctions, referring the victims to other support services and agencies within the community as needed. They help the victims evaluate the protective orders and modify them where necessary, and work closely with the Investigations Division. Victims Services are beginning to branch out, the goal being to contact the victims of all crimes, including burglary, theft and other assaults, to inform them of the status of their case. Historically, many crimes have been solved and the suspects arrested without the victim's knowledge. On occasion the victim learns of a possible suspect or finds additional evidence that would



make a difference, but is not contacted. The idea is to let victims know if their case is active or if it has been closed and why, and if there has been an arrest made. The Police Department is hopeful that this procedural change will result in more solved cases and bring closure to victims of crimes.


Neighborhood Watch and Citizen's Academy

Crime is a community problem, not a police problem. We are all members of this great community and we need your help. Go to www.stgeorgepolice.com and click on Public Information for the Neighborhood Watch program. Did you know that Neighborhood Watch is not a police program? It is a community program that neighbors initiate. Officers can be called to come to a meeting if needed, along with other City resources such as zoning officials, city engineers or legal representatives. You begin the program using the start-up agenda provided on the website. Your CAT officer can be there to show you how to get started and answer questions as you begin to make your neighborhood safer. The St. George Police Department Citizen's Academy is also a great way to see what the police are doing and the resources that are available to the crime fighting efforts in St. George. The Citizen's Academy consists of two sessions each week for eight weeks and every division and unit is showcased. There are presentations from the bicycle patrol officers, the Drug and Gang Task Force, the Bomb Squad and the SWAT team.

One father called and wanted to know if it was safe for his daughter to go to school. He didn't know about our school resource officers or our resources to deal with major incidents. We find that most citizens are only somewhat familiar with the resources available to them through the St. George Police Department.

On the popular CSI TV programs, investigators go out on every crime scene and come up with the suspect in 40 minutes. Before the hour is up, the case is solved and the suspect is in jail. But is that reality? Come to the investigations segments to see the real CSI aspect: fingerprint processing, death and homicide investigations, along with fraud and identity theft investigations. An application for the Citizen's Academy can be obtained by contacting the Police department and leaving your name and address. A limited background check will be done to make sure we are not divulging our processes to the wrong people, and you will receive a letter of acceptance along with the schedule for the next Citizen's Academy which begins the last of January and will be every Tuesday and Thursday from 6:00 to 8:00 pm. E-mail charding@sgcity.org and ask for an application, or stop by the station and pick one up. Best of all, there is no cost for this valuable presentation and instruction. As a department, we strive for good customer service to members of our community. Along with that service, we promote the participation of citizens so that we have a community that is prepared to adapt to any crisis and has a vision to shape the future.

New City Rental Ordinance

inside stuff

As St. George continues to develop, issues surrounding that development are becoming more sophisticated and complex making it necessary for the City to adopt new ordinances and revise old ones in order to maintain a quality of life that we come to expect as citizens. The City is not only responsible for creating and revising local ordinances but also enforcing them. The Code Enforcement Division for the City of St. George has the responsibility for the enforcement of the Zoning Ordinances - Title 10, the Nuisance Ordinance - Title 4 Chapter 2, the Sign Ordinance - Title 9 Chapter 13, the Home Occupation Ordinance - Title 3 Chapter 7 and the Rental Fit Premises Ordinance - Title 4 Chapter 7. The most recent addition to these responsibilities is the Rental Fit Premises Ordinance. This ordinance was adopted by the City Council in December 2005 with an implementation date of March 1, 2006. The purpose and intent of the ordinance is to monitor and regulate the habitability and safety of rental dwelling units within the City by providing specific guidelines to landlords and tenants regarding the minimal standards of habitability and to provide remedies for violations of such standards. There are several sections

within the ordinance that accomplish the defined purpose. The sections include



provisions for requiring a business license for landlords, rental dwelling unit inspections, duties and responsibilities of the landlord, duties and responsibilities of the tenant and a process for repair of deficiencies. The enforcement process begins with identifying property owners who have three or more rental units within St. George. These property owners must acquire a business

license and the rental units must be inspected by a Code Enforcement Officer. But, the inspections are only conducted every three years. Beginning January 1, 2007, all rental property owners must obtain a rental dwelling business license. The cost of the rental dwelling license is \$50.00 plus \$10.00 for the local agent. The inspection fee is \$25.00 per unit per inspection. A rental dwelling license is not transferable between persons or structures. If the property is disposed of, the holder of the rental dwelling license must give the city written notice within thirty (30) days of disposing or, transferring the property. The new owner must obtain a rental dwelling license. Furthermore, if the property owner does not reside within Washington County, he or she must designate a local agent or property manager within Washington County. The Code Enforcement Officer's inspection is commonly done with the property owner or representative in attendance; this way any deficiencies can be clearly identified for repair. Typical deficiencies include lack of smoke detectors, electrical outlet covers and proper gas heater ventilation. We also inspect for structural integrity, adequate water pressure and temperature, cooking facilities, sanitary facilities, heating, cooling and exterior landscaping. When a deficiency is identified we provide the landlord or property manager with a courtesy notice informing them of the problem and providing a reasonable deadline in which to complete the repairs. In some cases a notice of violation is necessary. This notice also provides a deadline, and fines are imposed for each violation that is not repaired within the required time period. Additional detailed information concerning the rental dwelling business license and the duties and responsibilities of the landlord, duties and responsibilities of the tenant and the process for repair of deficiencies can be found by visiting our website at: www.sgcity.org.

Heritage Days Celebrates 145 Years

St. George and the surrounding area is not only home to incredible natural beauty but is laced with vibrant heritage. For thousands of years many civilizations have called the majestic sandstone mesas and the volcanic clad hills their home. Anasazi Indians entered the area around 200 BC and left approximately 1300 A.D. The reason for their sudden departure was likely associated with long-term drought conditions; however, remnants of their dwellings, rock art and other artifacts are left as evidence of their 1000 years of living in our desert community. Paiute Indians entered the region between 1100 and 1200 A.D. They were a relatively small tribe made up of smaller bands of a few hundred Native Americans in each band. The Paiutes hunted for deer, rabbits, mountain sheep and other animals. They added seeds, roots, berries and nuts to their food source and later raised crops along the rivers using irrigation. These crops included corn, wheat, melons, squash and various other vegetables. The first known contact



between Europeans and Paiutes was recorded by the Spanish Dominguez-Escalante exploration group who passed through southwestern Utah in 1776. There is a historical monument of their crossing located near the dinosaur tracks in Warner Valley. In October of 1861, under the direction of Mormon Church President Brigham Young, 309 families were called to settle the St George area for the express purpose of growing cotton, grapes and silk to export to the Civil War torn northern states. The area became known as "Dixie" because of the warm climate, southern location and the products the area was able to produce. The Utah Territory was officially declared a state in 1896 and St George officially established in 1862 is still referred to as "Utah's Dixie." Life was very difficult for these early settlers and pioneers. Intense summer heat, with little rainfall made it difficult to raise crops and flash floods would often destroy their crops and structures. However, they stayed and persevered and built several communities. These pioneers built the first Mormon temple in the west.



The St. George Temple dedicated in 1877 at a cost of \$800,000 stands today as a monument to those first settlers. George A. Smith, a first cousin to Brigham Young, affectionately earned the name of "The Potato Saint" when he urged the early pioneers to eat raw, unpeeled potatoes, to cure a troublesome bout with scurvy. Since potatoes contain a high amount of vitamin C beneath the skin, the early settlers were cured; thus, the name "St. George." This year St. George turns 145 years old and to celebrate the City of St. George is holding its annual Heritage Days festivities January 17 - 20, 2007. The St. George Pioneer Center for the Arts becomes the backdrop for an Old Fashioned Talent Show, two-day Traditions Fair and root beer floats with Mayor and the City Councilors on Saturday, January 20th. After root beer floats take the family and head to the Sand Hollow Aquatic Center for a free swim on the same day.


Need Help Getting Started?

City Still Dedicated to Finish 2005 Flood Projects

It's hard to believe that we are approaching the two-year anniversary of the January 2005 flood. So much has happened over the past few years, that it's difficult to remember how devastating the damage was to the citizens of St. George and Washington County.

Many do not know that 70 separate flood repair projects were identified within the St. George City boundaries at an estimated cost of almost \$11 million. This consisted of eight bridges, four roads, six parks, five trails, six water line projects, 11 sewer projects, nine power projects, 14 golf course projects, and eight miscellaneous projects. The City is working closely with the Federal Emergency Management Agency (FEMA) and other federal and state agencies to complete approximately 82% of these projects.

Additional projects included dredging 558,000 cubic yards of silt and debris from the Virgin River and Santa Clara River. This amount of silt would fill more than 2 ½ football fields at a depth of 100 feet (approx. 10 stories tall). Immediate removal of the debris was critical due to severe threats of more flooding from snowmelt runoff and unusually extensive rain storms in the spring of 2005. Without removal of the debris, experts estimated the spring runoff would cause damage to public and private property greater than that caused by the January 2005 floods. City staff also assisted Washington County who worked with the Natural Resource Conservation Service (NRCS) to rock armor 26.5 miles of the Santa

Clara and Virgin River channels from Enterprise to Bloomington. The NRCS also has plans to armor part of the Virgin River near the Sun River development.

St. George has worked diligently to repair or rebuild all damaged structures and facilities. Those projects which are not complete are the result of following a complex process in order to insure that environmental concerns are addressed and "out of pocket" costs to the tax payers in St. George are minimized. Although they have taken longer to repair, the City has full intentions to repair all of the damaged facilities.

Mathis Park

Many citizens inquire as to when Mathis Park will be rebuilt. The nature of flood damage to Mathis Park created several significant delays to its reconstruction. The first major delay is that the access road into Mathis Park was completely destroyed by the flood. The City rebuilt Bloomington Park, Blake Memorial Park, and Tonaquint Park. However, unlike these parks, Mathis Park could not be immediately accessed to start reconstruction. Hoping to quickly begin reconstruction, the City negotiated to purchase property for a new access road; however, after several months, the negotiations were unsuccessful and abandoned. Mathis Park was also an important site for the NRCS channel armoring project. Until the NRCS completed the rock work, final contours of the river and the location for the access road


and parking lot could not be determined. This section was completed in early summer of 2005 and until then, the width of land available for the access road and parking lot could not be determined.

Reconstruction was delayed a few more months while the City worked with FEMA to determine the amount of soil lost at four of the parks, which included Mathis Park. FEMA's determination was issued in September 2006. Patience proved very worthwhile as FEMA approved a substantial amount of assistance to build a new City park.

The City is now proceeding with formal project designs, construction bids, FEMA's pre-construction review, and finally – reconstruction of Mathis Park. Because Federal funding is involved, the City must closely follow both Federal and City regulations through all stages of the project; therefore, the City anticipates construction will not begin for several months; yet is optimistic it will be completed by August 1, 2007.

Main Street Trail Bridge

Along with Mathis Park, we receive many questions regarding the Main Street Trail Bridge located by the Dixie Center and the confluence of the Santa Clara River, Virgin River, and Fort Pierce River. The trail bridge is an integral part of the City's trail system as it connects the Virgin River, the Hilton Drive, and the Bloomington Trails.

After a lengthy process to properly engineer the new structure, complete an Environmental Assessment, work with affected property owners and governmental agencies, trail enthusiasts will be excited to know that new bridge should be opened in mid January, 2007. The City, FEMA, the bridge manufacturer and local contractors are making a concerted effort to build the bridge in an extremely short time frame.

The new trail bridge will be more than twice as long as the previous bridge. It will span 206 feet and be located approximately 155 feet downstream from its original location.

Virgin River Trail III

Phase III of the Virgin River trail is the portion of trail paralleling East Riverside Drive from the River Road Bridge and extending past the Dinosaur Tracks building.

Approximately 3,500 lineal feet of this trail was partially or completely destroyed. A portion of the trail can be rebuilt in its original location; however, due to the river's shifting, a significant portion of the trail is now located inside the river channel. The realignment has created delays but City staff has been working steadfastly to establish a new trail alignment and obtain the necessary easements. These easements must be secure before FEMA will allow the City to move forward with an Environmental Assessment, design, bids,

and re-construction. We are close to taking the next step in this process, nevertheless, because Federal funding is involved, the City must closely follow both Federal and City regulations through all stages. We anticipate re-opening the trail by August 1, 2007.

Overall, even though there are only a handful of projects remaining and a couple years have passed, we will not forget the community spirit; volunteers; contractors; public safety personnel; federal, state, and local government cooperation; local businesses, and many other efforts which have enabled the citizens of St. George to recover from the flood of 2005.

Centennial Park Greenhouse

Ever wonder where all those beautiful flowers and plants in the downtown area come from? Many of them start out as seeds or cuttings grown by the Parks Division in the greenhouse at Centennial Park. Horticulturists Shane Moore and Paul Walker work with their staff under the direction of Larry Fredrickson to continually rotate annual and perennial plants for each season. The greenhouse is currently bursting with winter color waiting to be planted in walkways,



roundabouts, or the Bluff Street Fountain. The Parks Division shares the greenhouse with the School District who introduces young students to the delightful experience of propagating ornamental plants and vegetables. The greenhouse has been so successful an additional greenhouse will soon be added. The Park

Division is fortunate to have the resources of many green thumb employees. Some of the plants from the greenhouse are taken to the park's tree farm to

continue growing into shrubs and trees. The tree farm has been developed by our City Forester Doug Wulfenstein and his staff Tim Hopkinson and Debbie Scarbrough. Doug, Tim, and Debbie are Certified Arborists who keep the City's urban forest healthy. Centennial Park also invites the local neighborhood to discover gardening with its community garden box section. Neighbors of the park can plant a vegetable garden right in the park. Other features of the park include a softball field, an amphitheater, covered picnic areas and rolling hills of grass to keep young park patrons busy. Centennial Park is one of the many neighborhood parks the Leisure Services Departments provides to residents. They are designed to be as close to homes as possible. Other park facilities near Centennial Park include Slick Rock Park with its unique climbing rock playground, 2450 East Park with a walking path, picnic areas, basketball court and a volley ball court. The park is also close to the City's trail system and the Dinosaur Museum.

Parks, Recreation, Arts and Trails Master Plan

On October 18 the city council adopted the Parks, Recreation, Arts and Trails Master Plan which will guide the efforts of Leisure Services Department for the next 10 years. The plan was prepared by Landmark Design in Salt Lake City and includes analysis of existing programs and facilities of the Leisure Services Department, information from surveys and focus groups, new maps projecting facility needs, and recommendations for new programs, processes and facilities. The master plan included new definitions for neighborhood and community parks, and established levels of service for parkland.

The adopted standard for neighborhood parks is four acres per thousand residents and six acres per thousand residents for community parks. It is projected that the city will add approximately 172 acres of

community parkland in the next 10 years as our population grows to a projected 113,000. Additionally, it is expected that the city will add another 188 acres of neighborhood parks. Council adopted a policy of mandatory dedication which



requires that new development donate four acres of neighborhood parkland for every thousand residents projected within the new development. New development will also be required to link with the main system of trails. Park

impact fees will be the primary revenue source used in the development of new parks and trails. The Leisure Services Department continues to build projects which enhance the quality of life for our residents and visitors. Projects currently under construction include Forest Park in the Middleton area, The Field Park in Little Valley, upgrades to Dixie Downs and Middleton Parks, Brooks Pond Park on North Main Street, and the Main Street Trail Bridge over the Santa Clara River. Projects under design include the Willow Run Park in Green Valley, additions to the Tonaquint Park and Nature Center, The Fields Phase II, the Virgin River Phase III Trail rebuild, the trail from Bloomington to Sun River, and several splash pads and restroom additions in neighborhood parks. Watch for frequent updates on construction on the city website as well as dates for ribbon cuttings and grand openings.



Harry Miller, SunTran and Sand Hollow



William Volker Company and a retirement to St. George in 1991. And we come to the year 2000.

After having knee surgery, Harry's enjoyment of the water turns to a necessity as swimming becomes one of the only ways that he can rehabilitate his knees. He begins swimming at the Sand Hollow Aquatic Center and the benefits to his health are remarkable! The Aquatic Center is in the city of St. George but is bordered by the City of Santa Clara and Ivins. It includes a 25m by 25yd competition and diving pool and a 5,800 s.f. leisure pool. The leisure pool has a zero depth entry area, interactive children's water fun toys, a water walk and water slides. The water temperature in the Leisure pool is a comfortable 90 degrees and the competition pool is a cool 82 degrees!

Fast forward a bit more. The effects of a condition known as dry macular degeneration, which affects his vision, prohibits Harry from driving and getting his weekly swimming workouts in at the Sand Hollow Aquatic Center. Is all lost for our hero? Thankfully not, fast forwarding one last time brings us to the present day and Harry, with a little help from the City of St. George's SunTran public transit system, has still been getting his swimming in.

Despite the SunTran already offers more than sixty stops throughout the city, they are more than willing to make special accommodations because of Harry' disability. The SunTran buses make special stops at the Sand Hollow Aquatic Center (i.e the SHAC) so that Harry can visit it three to four times a week. Harry has come to prefer the SHAC because of its cleanliness and because of the friendliness of its staff, most of whom know Harry. In fact, many of them associate the SunTran buses with Harry and when they see one coming down the hill into the SHAC's parking lot, they will just go ahead and log in Harry's attendance.

Press play. The year is 1942. Our hero, a then sixteen year old Harry Miller, enjoys the water so much he becomes a lifeguard. Press the fast forward button and we move through a life that, along with his enjoyment of the water, has given him a marriage of sixty years to his wife Joy, four children, six grandchildren and four great grandchildren, a stint as the Vice President of the

Once the SunTran bus has dropped him off, Harry heads inside the SHAC and gets to the business at hand. His knees have long since regained their old vigor, but with a workout that focuses on the Freestyle (i.e. the front crawl) and the Breast Stroke, Harry is no featherweight to take things easy. Instead, he now swims upwards of an hour and does dozens of laps every time he comes to the SHAC.

After completing his strenuous work out and making use of the SHAC's excellent showering and locker room facilities, Harry waits in the lobby of the SHAC for his bus to come. At 11:30 on most days, a SunTran bus pulls up and whisks him away. And on those rare days when traffic is heavy, the SunTran drivers will call the SHAC staff, who will then pass the message onto Harry. Being the demur type of person he is, Harry can't claim to have a favorite driver, but this catering to his needs is what endears the SunTran experience to Harry.

And so it was with his son Roger assisting him in getting to the starting blocks and the rest of his family cheering him on, that all of Harry's swimming paid off as he swam in this year's Huntsman Senior Games. Swimming competitively in events such as the Freestyle and Breast Stroke, Harry did very well, winning a Silver Medal in the 50M Breast Stroke with a time of 1:42.70. Hoping that more fast forwarding will show even better times next year, Harry is grateful for the Sand Hollow Aquatic Center and plans to continue his swimming.

The City of St. George recently received a “Healthier You Legacy” award for its work to create a healthy community.
